The HSAC recommended expansion of chiropractic benefits to include unlimited examination/re-examination per medical necessity. The committee recommended expanded diagnosis of acute and chronic spinal conditions, as well as NMS conditions. The committee also added billing of therapeutic exercise and manual therapy to covered services. **Please note:** This has not changed in legislation yet! We need your help! A bill will be dropped by DHS this year to change the existing statute and add to the Governor's budget. Come join us at <u>Day at the Capitol</u>. Auditing: The MN Board audits annual CE for 100% of our licensees. After you renew your license for the upcoming year, you will receive a request for documentation of your continuing education for the current year, prior to renewal. Please read all notices with care, and follow the CE Upload instructions carefully.

Important CE Updates

- MBCE has moved to an annual audit. Be sure to turn in all your hours before the deadline.
- Minnesota CEs are approved only through MBCE and PACE. Be sure to list the
 course approval number on all transcripts or certificates when submitting them. If the
 approval number is missing, you will not receive credit.
- Make sure you have your correct license number listed. A missing or incorrect number means you will not receive credit.


