### Association News

Welcome to 2023!

We start out the year focused on legislative agendas. In case you missed it, here is our latest update.

Week of January 16, 2023

***The Minnesota legislature has turned into a bill producing machine.*** A recent update revealed that the Revisor, the office that writes the bills, is currently working on drafting 3000 plus bills. This has led Speaker Hortman to intervene by issuing a rule that bill drafting requests must come directly from a legislator and not a member of the public such as a lobbyist. In some cases, legislators have given members of the public permission to make a request to the Revisor on their behalf, but going forward that will not be the case for the House. With work piling up at the Revisor's office, we have seen delays in getting bills drafted. One possible reason for the uptick in these requests may be due to the limited numbers of bills that have passed in the recent past, so many of this year's bills are items that are recycled from last session.

This week we also started to see parts of the Governor's budget be revealed. Tuesday, the Walz administration announced a \$12 billion package focused on children, youth, and families, followed a few days later by a high level summary of his proposals for the climate and economy. It is anticipated that a high level summary of the proposals for health, housing, and public safety will be released on Monday. The full budget will be released on Tuesday of next week.

#### **Items of interest to the MCA:**

Senator John Hoffman, Chair of the Senate Human Services Committee, has agreed to carry our Medicaid expansion bill. Representative Jess Hanson has agreed to carry out termination without cause bill in the House. We will continue to collect additional signatures on these bills and to identify strong authors in the other bodies.

SF506 will be introduced in the Senate on Monday by Senator Kelly Morrison (DFL). This bill would impose a 2% tax on health plans for all paid claims. This implements a new revenue stream for the Health Care Access Fund (HCAF). The impact would be that by generating more revenue, it would keep the HCAF in a surplus status. When the HCAF has a surplus, it triggers a contingency factor that reduces the provider tax. So the impact of this bill would be to effectively eliminate the provider tax without actually repealing it. We will engage on this bill to assess its potential for passage. Thank you to Senator Jim Abeler for being a coauthor on this bill.

Lastly, an email was sent earlier this week asking for MCA members to consider applying for two open positions on the Health Services Advisory Committee. We were specifically asked by DHS to identify interested applicants, so this a great opportunity to advance chiropractic in the state. Please let us know if you have any questions about the Committee.
